Poland: Increase in VAT on January 1st, 2011

Dear customer,

On January 1st, 2011 the Polish VAT rate will increase from 22 % up to **23 %**. So all end user prices in all number ranges will increase accordingly.

In general:

(in English: "Cost of the call X,XX PLN / Y,YY PLN incl. VAT per 1 minute")

708 6 numbers:

"Koszt połączenia 3,46 PLN / 4,26 PLN brutto za 1 minutę"

708 8 numbers:

"Koszt połączenia 6,25 PLN / 7,69 PLN brutto za 1 minutę"

This VAT increase will have no influence on the payouts which remain the same.
